School-Parent Compact

 - Parent teacher conferences will be held before school; 7:00-7:45 a.m. and/or after school from 3:00-6:00p.m. (a mutually agreed upon time), and during the teacher's planning period as the need arises.

- 3. Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:
 - Parents will be provided with a mid-term report each quarter. This report will be sent home in the scholars' "Tuesday Take Home" folders. Beginning the second quarter, parents of scholars in grades 3-8 should be able to access grades online via the parental portal in PowerSchool.

- 4. Provide parents reasonable access to staff.** Specifically, staff will be available consultation with parents as follows:
 - Parents will have access to staff via telephone during planning time, before and afterschool, emails, Dojo, and face-to-face conferences.
 - Parent teacher conferences will be held before school; 7:00-7:45 a.m., after school from 3:00-6:00p.m. (a mutually agreed upon time), and during the teacher's planning period as the need arises.

- 5. Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities,** as follows:
 - GSA has a volunteer program at the school that allow parents to volunteer in the school and in their child's classroom.
 - Parents are encouraged to volunteer throughout the day, beginning with scholar-drop off, during the day in the classroom as instructional assistants, in the office, media center, and in the afternoon for scholar pick-up.
